Chelford Parish Council has concerns regarding the suggestion within budget item 105 to, "reduce the number and timing of street lighting in the borough from September 2023. Options will be reviewed to consider priorities and safety aspects associated with turning off alternate lights or turning

lights off in the early hours of the morning in some areas."
Whilst it is appreciated that the detail of this proposal had not yet been published, there is concern that the proposed reduction in number and/or operation of street lights within the parish of Chelford could have a significant detrimental impact upon residents. The provision of street lighting within the parish is considered vital to ensure that all residents, including elderley, disabled and young people, are able to safely navigate the parish, outside of daylight hours, to reach services, facilities and family/friends.

Many areas within Chelford have poor quality footways which, during the darker winter months, can present an additional hazard to many pedestrians if there were limited or no street lighting. This increased risk for vulnerable residents is likely to limit the time period within which they would be able to access services, facilities and family/friends, thereby, diminishing the quality of life and independence of Chelford residents.

It is requested that a careful review of this proposal is undertaken to ensure that the potential detrimental impact of such a scheme does not disadvantage vulnerable residents who rely on street lighting to access services, facilities and family/friends. (All in favour)
