1. Damaged chevron sign at Chelford Roundabout
UPDATE: Planned work was abandoned due to safety concerns. The repair will be re-programmed for night work.
2. Street light out at Knutsford Road, to the east of junction with Dixon Drive
UPDATE: A new lantern has been ordered, however, delivery has been delayed from the manufacturer. The new lantern will be fitted upon receipt.
3. Street lights out at Chelford Roundabout, between Alderley Road and Chelford Road exits
UPDATE: Repairs have been delayed due to safety concerns and the loss of electricity supply to the columns.
4. Street light at at pathway between Elmstead Road and Woodfin Croft
UPDATE: A new lantern is required, however, installation delays have been encountered due to access to the lantern.
5. Overgrown hedge at Knutsford Road (1)
UPDATE: Awaiting assessment.
6. Overgrown hedge at Knutsford Road (2)

APPENDIX F

Highway Priorities 2023/24

Immediate priorities:

1. Review of zebra crossing at Knutsford Road
UPDATE: Response from Cheshire East Council:
 - The proposal for additional lighting to highlight the crossing will be passed to the Street Lighting Team for consideration.
 - The surrounding distraction is unfortunately the same for all pedestrian crossings and is reliant on driver/pedestrian action to maintain awareness of the crossing.
 - We agree that the use of full traffic signals would be more prominent however we cannot justify the large cost for implementing the proposal by Road Safety.
 - During our monthly Police liaison meeting the Police agreed that parking should not be occurring at the zig-zag markings on the approach to the zebra crossing, however, they did not offer any additional proposal. This month we will discuss the customer parking with the shop owners and will conclude as to what action can be taken.
 - Our site visit did not show failing to give way to pedestrians.
 - Road Safety funds require justification using the latest injury collision record. The current good safety record at this crossing does not validate such funding and unfortunately the proposed high cost cannot be met in the 2024/25 financial year. Also we are not aware of any relevant government funds that could assist such an upgrade.
2. Review of yellow lines at junction of Oak Road and Knutsford Road
UPDATE: Response from Cheshire East Council: Cheshire Constabulary data shows that over the last five years there has been one reported injury collision at this location. The data does not include damage-only collisions or near misses. The request has been added to the list of locations for consideration during prioritisation assessments which inform future work programmes.

High priority issues:

3. Review of options to tackle speeding issues within the Parish
UPDATE: Application for two new SIDs along Knutsford Road to be progressed.
Community speed watch to resume when permitted – reminder sent to Police for update.
Potential for average speed cameras to be assessed when initial pilot scheme at Plumley has been completed.
4. Footway surface condition along Knutsford Road from junction with Station Road to railway platform access
